## Gregory Rose '95 Elected President of Alumni Board of Governors



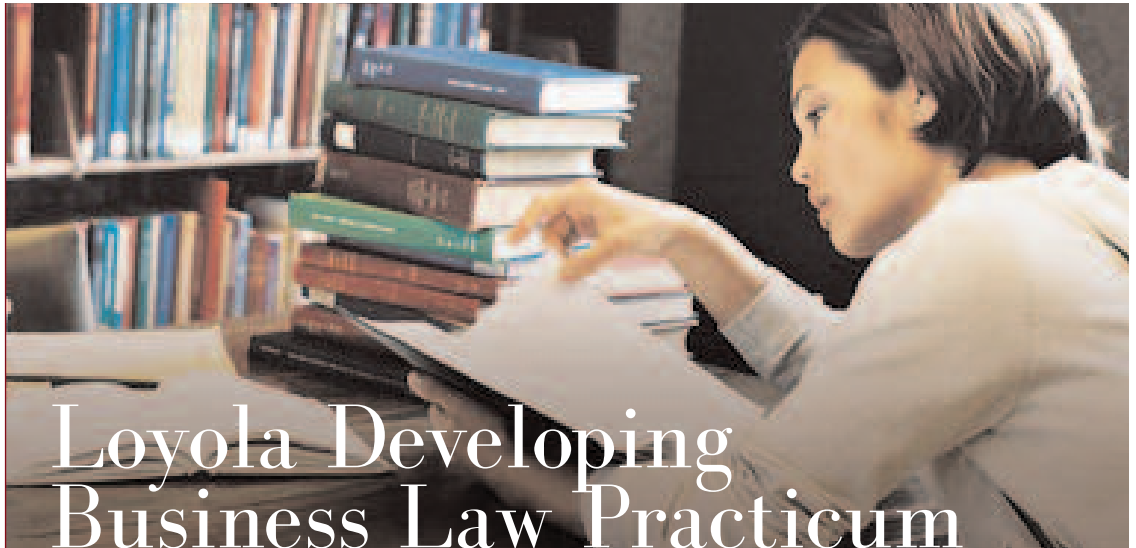

## Loyola Developing Business Law Practicum

Most law schools and law firms do not commit resources to developing lawyers who can hit the ground running. Loyola is developing its Business Law Practicum to fill this void, and it will offer a unique and innovative approach to educating business lawyers.

Loyola's Business Law Practicum will develop new materials that encompass an entirely new way of teaching deal-oriented law. It will allow students to study and understand transactions using a simulated deal format that will include a substantial focus on the ethical considerations that face the modern transactional lawyer.

The Practicum will include a capstone course, divided into two free-standing classes—Business Planning: Financing the Start Up and Emerging Growth Business and Business Planning: Selling the Business. Taken in the third year, these classes will allow students to study the entire life cycle of a typical business, and to synthesize and build on substantive law in a practical, real-world setting. Since the capstone course will ask students to review, draft and edit documents typical to a certain type of deal, the classes will simulate transactional work in a law firm and students will be evaluated as they would in a real law firm.

Alums like Robert Pardo '86 are enthusiastic about the program, saying, "I think the Business Law Practicum will provide students interested in a transaction practice with real-world knowledge and skills that will be beneficial to them as young lawyers and to the clients they serve. This will be a unique

program, and this type of innovative thinking makes me very proud to be a Loyola alum."

The Business Law Practicum represents a new way for Loyola Law to continue to prepare its students for success and to contribute to the legal profession. Please contact Professor Therese Maynard at [therese.maynard@lls.edu](mailto:therese.maynard@lls.edu) with any questions about this new program.

2005. Masry gained worldwide fame from the Oscar-winning movie *Erin Brockovich*, which was based on Masry's \$333 million settlement against Pacific Gas & Electric Co. Masry served in the Army in France before earning his JD from Loyola Law School. He began his private practice in 1961, and was also an agent for NFL players. He served the Thousand Oaks City Council for five years. **Judith T. Gibson '87** died on July 6, 2005. **Philip A. Erickson '88** passed away on September 15, 2005. Erickson, who practiced law in Ventura and was known as one of the most ethical attorneys in town, is survived by his wife Maeve and his mother, sister and brother. **Zara Buggs Taylor '88**, who retired last year from the Writers Guild of America, west, died. Buggs Taylor was an advocate for minorities, women and the disabled in the television and film industry, and a vocal advocate for writers. **Lori Engelhorn Glazer '97** passed away on December 9, 2005. Following law school, Engelhorn Glazer practiced law at the Children's Law Center in Los Angeles. She is survived by her husband Michael, her sons Joshua and Benjamin, her parents, grandmother, sisters and nieces.

A US District Court judge for the Central District, he was a well-respected member of the bench. Following law school, Byrne clerked for the US District Court and then served in the Air Force, conducting courts-martial during the Korean War. Byrne worked as a prosecutor in the US Attorney's office and also in private practice. He was appointed to the Commission on Campus Unrest, which investigated Vietnam War protests, by President Nixon. Nixon later named him to the federal bench. Byrne is survived by Superior Court Judge Richard "Skip" Byrne and attorney Mark Byrne.
