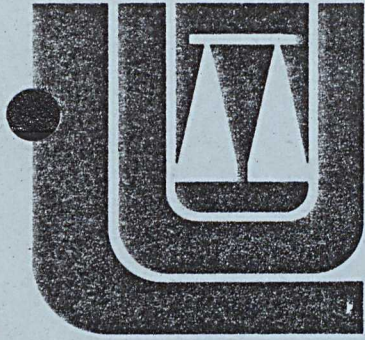

A MESSAGE FROM DEAN FRAKT

There has apparently been some confusion with regard to which dean has responsibilities in which areas of the law school program. Assistant Dean Arnold Siegel has overall supervisory responsibility for all aspects of the law school program relating to student activities. These include the Admissions office, Financial Aid office, Placement office and the Registrar's office. If any student has a problem or question concerning any of these aspects of the law school program and it is not resolved within those offices, Dean Siegel is the person to see. Any other personal or professional problem which a student wishes to bring to the attention of the law school administration should also be directed to Dean Siegel's attention.

Associate Dean Dan Stewart is charged with the responsibility of general administration of the faculty and courses of study. There is necessarily some overlap between Dean Siegel and Dean Stewart's functions where student problems arise through academic concerns. For example, when a student feels that there is difficulty with a particular professor or class, the initial contact should be made with Dean Siegel.

Assistant Dean Leo Ramos is charged with responsibility for the business administration of the law school. Thus, he has general supervisory authority over the Personnel office, Student Accounts office and ancillary services such as the cafeteria and the bookstore as well as our general budget and building programs. Again, there is some overlap between the functions of Dean Siegel and Dean Ramos. For example, when a student has questions or problems with tuition payments, he or she is to see Dean Ramos.

If a student feels that he or she has not received satisfaction at the assistant deans level, then that student should feel free to raise issues with me.
