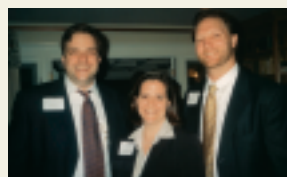
**ENTERTAINMENT LAW LUNCHEONS COVER ETHICAL ISSUES AND GENDER BIAS**

**IN MEMORIAM** **Hon. Richard J. Curran '50** passed away on January 12, 2005 at the age of 88 from stroke complications. Judge Curran served with the U.S. Army Air Force in World War II, and retired from service as a captain. He was appointed in 1964 to the Municipal Court bench in San Diego at the same time his brother, Frank, was serving his second term as the city's mayor. Curran retired from the bench in 1984. During his tenure, he helped to establish the San Diego Unified Port District and revise the municipal code. He also mentored young attorneys. Curran is survived by his wife of 46 years, Kathy, and a daughter, granddaughter and great-grandson. **Hon. Floyd H. Schenk '50** died of complications from Alzheimer's. He was 82. A resident of Newport Beach, Judge Schenk was retired from the Orange County Superior Court. Schenk served in the Navy during World War II, and following his law studies, practiced law in Hollywood. He later opened a branch office in Palm Springs. Schenk is survived by his wife, five children, a grandchild and two great grandchildren. **Justin M. McCarthy '53**, a longtime Riverside attorney practicing eminent domain and water

cases, died on October 23, 2004 of heart failure. He was 78. McCarthy was a partner with Redwine and Sherrill, where he practiced for 44 years.
