Under our new probationary and disqualification rules, students who complete their first year with averages between 70 and 74.5 will be readmitted on probationary status and will be required to repeat all courses in which they received grades below 70. There is no re-examination procedure for first year students. There are a variety of other probationary conditions and similar restrictions on upper class students with unsatisfactory averages.
