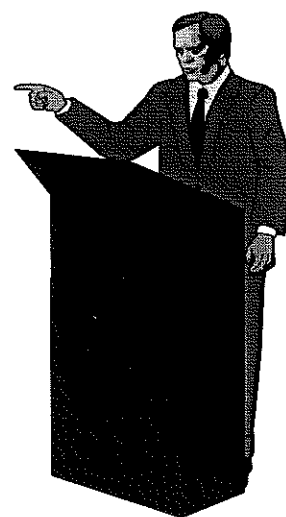

Nancy Sher Cohen Named Trial Attorney of the Year

Nancy Sher Cohen '78 has been selected by the Alumni Association Board of Governors to receive the "Trial Lawyer of the Year Award" for 1998. The award will be presented to Cohen at a dinner preceding the Scott Moot Court Honors Board Competition Final Round on Wednesday, April 15, 1998, at the Law School.

Managing shareholder of Heller, Ehrman, White & McAuliffe since 1995, Cohen is a highly skilled litigator with a wide variety of experience. She has handled mass tort and complex multi-jurisdictional tort actions, been lead counsel in the prosecution of several insurance coverage lawsuits related to environmental and produce liabilities, and has brought about creative settlements of mass tort actions, including certification of the first mandatory non-opt-out settlement class in California state court (the so-called "Cremation Cases"). She was involved in the settlement of the breast implant litigation and the Lockheed Skunkworks litigation on behalf of 3M. She also has been involved in extensive entertainment litigation, including acting as co-counsel for Clint Eastwood in the *Locke v. Eastwood* case and lead counsel for Michelle Pfeiffer and David Kelley in an alleged copyright violation case. Cohen represents the American Association of Retiree Persons in litigation and counseling in connection with insurance, health care and business issues.

Cohen also spends considerable time in community and professional organizations. She is currently vice-chair, Insurance Coverage Litigation Committee, TIPS Section of the American Bar Association, and a member of the Board of Directors and President Elect of Bet Tzedek Legal Services.

The Scott Moot Court Competition Final Round is the culmination of several days of elimination rounds. The Final Round will be judged by an impressive panel that includes The Honorable David Trager, U.S. District Court, Southern District of New York, and The Honorable Ming W. Chin, Supreme Court of California. The third panelist will be named shortly. Dinner attendees are invited to attend the Final Round

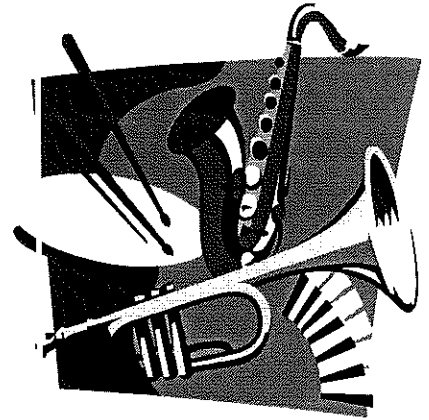

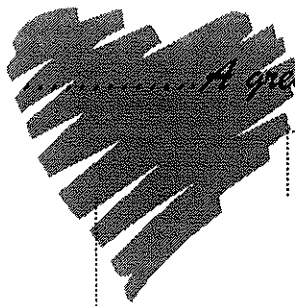
