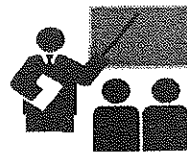

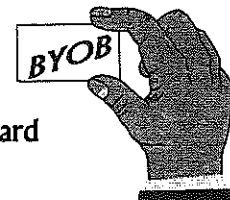

The law school experience of the Class of '82 was no different than most. We entered alone, but for most of us we left together, each of us having benefited from, endured, and in some instances, suffered through three years which would forever change our lives. We talked about the bright future, the imminent bar exam and our desire to make an impact on the world with our new status.

Eighteen years later many of us have or are in the process of making that impact. We have fanned out to different states and countries. But, what happened top that bond we felt on graduation day? During our infrequent discussions, we talked about how busy she was in Washington, D.C., and how busy I was in Northern California. We never found the time to get together. However, since Ellen's death, several of her classmates have re-established contact, and for that we are all grateful. However, it is unfortunate that it took a tragedy to spark this reunion. Thanks, Ellen, for the memories. We will miss you.

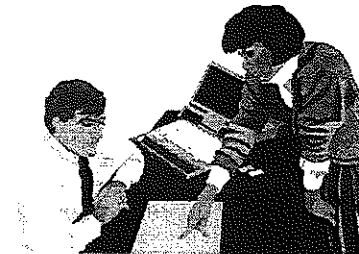
