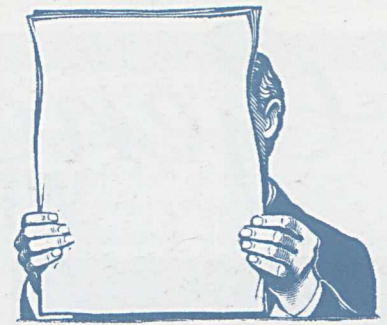

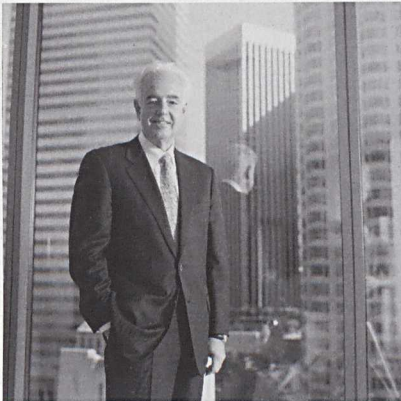

Only once a year are you, the alumni of Loyola Law School, provided with the opportunity to gather with more than 600 of your classmates and other alumni, faculty and friends for a relaxing evening of conversation, networking, and just plain enjoyment. So, don't miss out on this year's Grand Reunion on Thursday, April 10, 2003, which will be held at a new location: the Wilshire Grand Hotel in downtown Los Angeles. All alumni and friends of Loyola Law School are cordially invited to attend. Invitations are in the mail.

During the evening, the 2003 Distinguished Alumni Award will be presented to the Honorable **Kathryn Doi Todd '70** of the California Court of Appeal, Second Appellate District, and **Thomas J. Nolan '75** of Howrey, Simon, Arnold and White, Los Angeles.

Upon admittance to the bar in 1970, Doi Todd was one of only three Japanese-American women practicing law in Los Angeles. In 1978, Doi Todd broke entirely new ground when she became the first female Asian-American judge in the country. Intrigued by understanding and construing the law, Doi Todd rose through the judicial ranks; from the Los Angeles Municipal Court she advanced to Superior Court, where she was the presiding judge over the Los Angeles County Juvenile Court, the nation's largest. During her judgeship with the Superior Court, Doi Todd was bestowed with the great honor of an appointment to the California Judicial Council, the policymaking body of the state's courts. In August of 2000, Doi Todd became an associate justice for the California Court of Appeal, Second Appellate District.

Nolan is managing partner of firm operations for Howrey, Simon, Arnold and White, specializing in antitrust, intellectual property, securities litigation and white collar criminal defense. He has handled several landmark cases, but the one bringing him the most satisfaction was victory in a *pro bono* case involving 59 plaintiffs and the death of a child due to slum housing conditions. "All of my success has been the result of working with incredibly talented lawyers from whom I draw insight," Nolan says. "Loyola taught me to commit to excellence in life, friendship and work."

The 2003 Alumni Association Board of Governors Recognition Awards will be presented earlier in the evening at a private awards ceremony to: **Brian C. Nutt '83** of Thon, Beck, Vanni, Phillipi & Nutt; **Robert A. Cooney**, former associate dean for business affairs; **Cristina Armenta '94** of Skadden, Arps, Slate, Meagher & Flom LLP; and **Patricia Phillips '67** of Morrison & Foerster LLP.

Initiated in 1997, these awards are bestowed in recognition of outstanding community service to the Law School, the legal profession and the community at large. Also during the awards ceremony, the Class of 1953 will celebrate its 50th year class reunion, and the late Professor **William (Bill) C. Hobbs** will be honored posthumously with the 2003 St. Thomas More Medallion, which will be presented to his daughter. Hobbs devoted his life to teaching mediation and trial advocacy skills. Hobbs served as associate clinical professor at Loyola Law School beginning in 1971, and as the director of The Center for Conflict Resolution at Loyola Law School from 1994 until his passing one year ago.

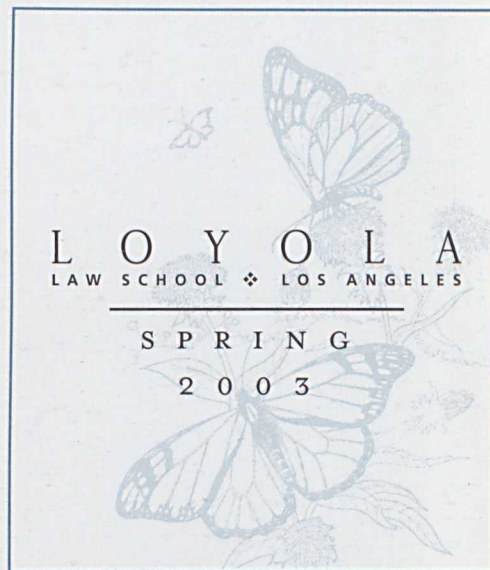
