Loyola Law School Kicks Off \$40 Million Endowment Campaign

Loyola Law, under the leadership of David W. Burcham '84, Fritz B. Burns dean and professor of law, launches its \$40 million endowment campaign with a donor appreciation gala celebration on April 16, 2005.

This section can **ONLY** be viewed by the Office of Alumni Relations and you.

To select the information you would like classmates to be able to view, click "My Preferences." Alumni are encouraged to display employment information and areas

of practice—this information will allow fellow alums to communicate, network and provide referral opportunities through the alumni online directory.

Another component of LAWnet is "My Giving," which provides a current overview of your history of giving to Loyola Law. Also, online giving is now available. Through LAWnet, you can select from a number of giving options and donate securely and confidentially.
