# TRIAL ADVOCACY AT LOYOLA LAW SCHOOL

*Many alumni (ae) are only casually aware of the substantial changes which have been made in the curriculum at the Law School in recent years. In the last issue of the Loyola Lawyer the Clinical Program was featured. In this issue we focus on the Trial Advocacy Program. From time to time we will present additional articles on the training of Loyola Lawyers.*

Trial advocacy plays a significant role in the curriculum of the Loyola Law School. In furtherance of its commitment to the concept of teaching Trial Advocacy, several years ago two new courses were instituted: "Civil Trial Advocacy" and "Criminal Trial Advocacy." Both are three credit courses and are limited in enrollment to 25, thereby insuring a high degree of personal attention. Both courses have been extremely well received by students and faculty. By offering four sections of each course, some 200 students are able to benefit from this advocacy training each year.

It should be noted at the outset that many law schools which have an advocacy program do not split Civil and Criminal but teach one generalized "Trial Advocacy" course. Loyola makes separate courses available on the theory that by the time students take these courses, usually in their final year of law school, they have formed a specific interest in either "civil" or "criminal" practice.

Civil Trial Advocacy is designed to analyze all aspects of the Civil Trial, including preparation for trial, settlement negotiations, the voir dire, jury selection tactics, opening statement, order of proof, direct and cross examination and closing argument. Students participate in simulated trial sessions, which are videotaped for later critique. Evidence is a prerequisite for the course.

Students are assigned individual cases to "try." One professor utilizes a critique form, two copies of which are handed out to each student. The forms are filled out in duplicate by the entire class for each student who handles a case. One copy is given to the professor (the critiques are themselves graded, in addition to court performance), and the other copy from each observing student is given to the student lawyer for that session. The students not on trial must also submit a written strategy for each trial after reading all transcripts, etc.; consequently the critiques are usually quite extensive.

Another professor has the students prepare factual situations usable as potential assignments. In fact, a third professor gives a final exam which utilizes "mini transcripts." Professors also use outside guest lecturers in specialized areas such as commercial litigation and malpractice. For example, in a session on valuation of property, Roger Sullivan, Esq., '52, was a guest along with Robert Beeney, an appraiser, and Judge Alexander Early, III, so that students were able to examine and cross examine with a real judge ruling.

In addition to "trial practice" skills the course also raises questions of ethical conduct by counsel. The above, along with advice, direction and conferences with the professors in conjunction with video tape playback are responsible for a very high degree of improvement for a student during the course of the semester.

The Criminal Trial Advocacy course offers students an opportunity to participate in a "mock" criminal trial, including pre-trial motions, voir dire, opening statements, direct and cross examination of witness (including experts), closing arguments, jury instructions and sentencing, with emphasis upon strategic and tactical

considerations. As with "Civil Trial Advocacy," trial sessions are video taped for critiques. A factor which makes this course particularly beneficial to the student, and a feature which is indeed unique to Loyola, is that this course is a prerequisite for the District Attorney Clinical Practicum. In the clinical program students are assigned to various branches of the Los Angeles District Attorney's office. Under the supervision of a trial deputy, students prepare and present misdemeanor jury and non-jury cases as well as conduct preliminary hearings in felony cases.

In recognition of the importance of trial advocacy to the overall training of a lawyer, Loyola Law School constructed a Trial Advocacy Courtroom. The Trial Courtroom, which is in addition to and a separate facility from the Moot Courtroom, has been provided with a remote controlled video-audio recording and playback system. Each course therefore can successfully use "simulation" as a basic teaching tool.

The above efforts in terms of curriculum, faculty and facilities are one very good reason for the high degree of competence exhibited by the Loyola Lawyers now being graduated.

The St. Thomas More Law Society is organized to consider and discuss ethical, moral, social, and political problems of interest to the legal profession, and to provide service to the law school. # Loyola University School of Law of Los Angeles Program of Continuing Legal Education

The Faculty and Administration of the Law School are keenly aware of both the rapidly changing needs of the legal profession and the demands being made on legal education. In 1974 a committee of faculty, alumni, practicing attorneys and students studied the need for a program of continuing legal education, the role Loyola Law School could play in satisfying that need and the demands such a program would make on the resources of the school. The committee was chaired by Professor Gerald F. Uelmen. Based on the committee's findings and recommendations a decision was made to undertake a pilot program of continuing legal education commencing in the Fall 1975. The financial support needed to begin the program was made available through the generosity of the donors to the annual Advocates fund drive.

In the Fall, 1975 two courses were offered: "The Prosecution and Defense of Drug Cases" and "California Land Use Control." Seventy-five attorneys from Los Angeles and Orange County attended the courses which were conducted at the World Trade Center. For the

Spring semester, 1976, over 200 attorneys have enrolled in:

- International Business Transactions
- The New California General Corporation Law; A Transactional Analysis
- Psychiatry for the Criminal Lawyer
- How to Open, Maintain and Operate a Small Law Office.

Faculty teaching these courses include: Professors Gerald F. Uelmen and Gideon Kanner, of the Loyola Law faculty; Professor Donald Hagman of the UCLA Law faculty, Vincent A. Narcisi, of Gibson, Dunn and Crutcher; Ronald L. Fein, Chief Deputy Commissioner of Corporations; Bruce L. Gitelson of Gibson, Dunn and Crutcher and Adjunct Professor at Loyola Law School; Selwyn Rose, M.D., Adjunct Professor, Loyola Law School and Director of the Van Nuys Psychiatric Hospital; and Gerald M. Singer, '68, Adjunct Professor, Loyola Law School.

Assistant Dean Michael Harwin is the coordinator of the Continuing Legal Education program.



## Loyola Law Student Partners' Association Sponsors Casino Night

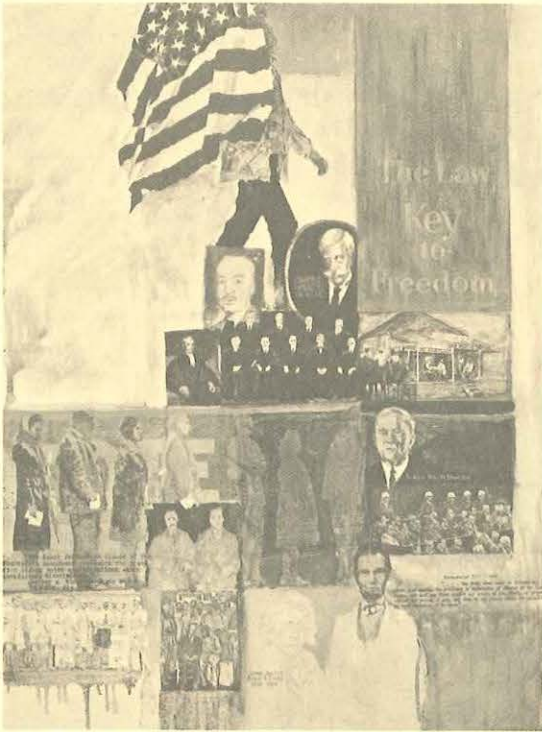

The Loyola Law Student Partners' Association contributes two scholarships awarded to one married day student and one married evening student.

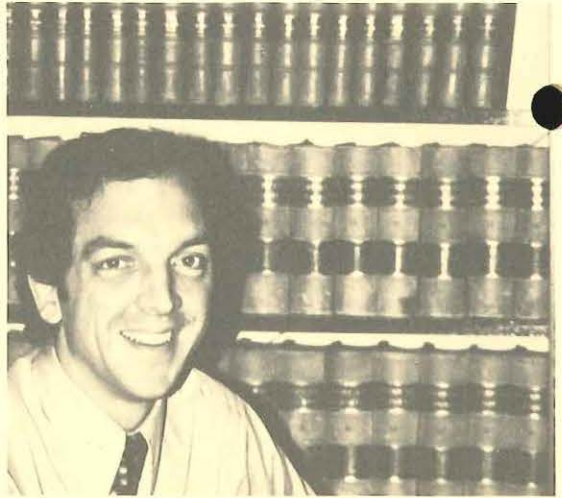


## David Tripp Wins National Lawyers' Art Competition

David E. Tripp, Class of 1973, won first prize in the 1975 West Publishing Company's national lawyers' art competition with his multimedia work, "The Law: Key to Freedom." Mr. Tripp won \$5,000 of the total \$15,000 that was awarded in prizes. His winning work appeared on the cover of the July 1975 issue of the American Bar Association Journal.



The West Publishing Company, located in St. Paul, Minnesota, sponsored the competition in observance of the American Bicentennial, as well as the West Publishing Company's Centennial.



Mr. Tripp stated that "the emphasis on the Supreme Court and its justices flows from my feeling that the interpretation of law is more important than the legislative process behind it." His work depicts Judge Roy Bean because he brought law and order to a then lawless land, civil rights marchers carrying the flag to represent the significant changes that they instigated, and Sacco and Vanzetti and the Scottsboro boys because of their notoriety and to demonstrate society's vow not to allow that kind of loss of rights again.

Raised in Dallas, Texas, David Tripp was encouraged in his drawing by his parents. He graduated from North Texas State University and attended the Art Center College in Los Angeles. He then travelled through Europe by earning his way as a portrait artist. After returning to Oxnard to work, he commuted to Loyola Law School at night and received his J.D. in 1973. He then worked in private practice before joining the Los Angeles County District Attorney's Office. He lives in Los Angeles with his wife, Barbara, and three small sons.

## Faculty and Administration Briefs

FATHER RAYMOND DECKER, Assistant Dean for Admissions, was invited by Ahmad Khalifa, a prominent Egyptian jurist, to attend a symposium in Aswan, Egypt, during January 1976. Dr. Khalifa, who is Chairman of the Board of the National Center for Social Research, in Egypt met Father Decker while he was visiting Loyola Law School this past Fall.

Twenty legal scholars throughout the world were invited to the symposium to address Egyptian legal scholars and to make legal recommendations to the Egyptian government which is in the process of changing its legal code. Father Decker was the only invitee from the United States.

He spoke on the changing role of American Penal Laws and his address showed the relationship between religion and penal law in the United States. He said, "What has taken place in Anglo-American penal law over the past 170 years has been something more than analytical descriptions — it is something deeply embedded in the socio-religious history of both Great Britain and the United States that we can call the entelechy of secularization. This process is in effect changing the very role of the penal law in Anglo-American society. Whereas once the penal law was looked upon as the enforcer of the prevailing religious ethic, it is now becoming the necessary protector of social adhesiveness by serving as the arbiter between conflicting philosophies and value structures. Through this reciprocity, involving at its root the process of secularization, the penal law has been assuming less and less the role of the enforcer, and more the role of the arbiter."

Father Decker said after his visit that Egypt is concerned with their penal code and wants to

research the examples of other countries. Their major concern is how the penal law could prevent crime.

Father Decker is completing his second year as Assistant Dean for Admissions at Loyola Law School and holds a Ph.D. in Religion and Law. He is a diocesan priest who came to Los Angeles from San Francisco.

ROBERT BENSON is the author of a regular column in the Journal of the American Bar Association entitled "Wine Briefs." The column began in January 1976 and is devoted to providing knowledge concerning the legal context of wine products and regulations of wine production.

STEVEN HIRSCHTICK conducted a lecture for the American College of Radiology in Las Vegas in January and will conduct a similar lecture in New Orleans in October. His topic will concern the professional corporations and pension plans. Mr. Hirschtick is Vice Chairman of the Legal Aid Committee and is a member of the Committee on Corporate Stockholder Relationships of the Section of Taxation for the American Bar Association.

GIDEON KANNER has received a grant from the Institute for Humane Studies to work on an article on constitutional limitations on land use regulation. Professor Kanner also participated in the first Urban Land Institute Conference sponsored by the University of San Diego School of Law in February.

MARTHA ROBINSON participated in a panel discussion on "Ethics and Discipline — 1976" at a luncheon meeting of the USC Alumni Association on March 23, 1976 held at the Music Center.

SUSAN SPIVAK is teaching the Day Section of Federal Income Tax I during the Spring semester. Ms. Spivak graduated from Pembroke College and received her J.D. from University of Pennsylvania Law School. She was then associated with the firm of Paul, Weiss, Rifkind, Wharton and Garrison in New York. She has taught tax courses at Arizona State, Boston University and Stanford Law School.

GERALD F. UELMEN was appointed by District Attorney John K. Van de Kamp to a seven member committee to evaluate the District Attorney's Bureau of Investigation.

Dear Fellow Alumni,



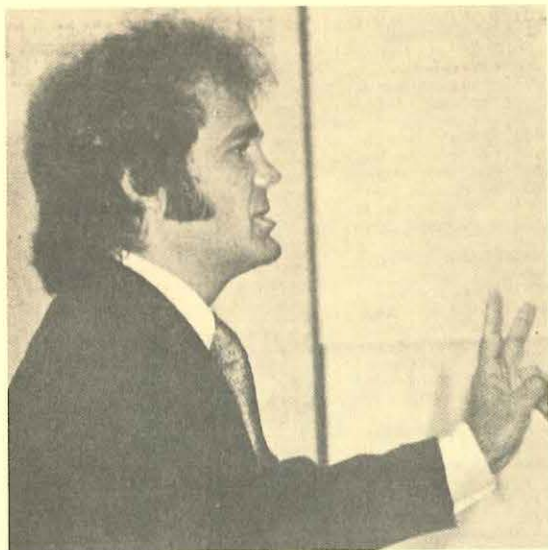
