VOLUNTEERS NEEDED...to assist with the granting of United States citizenship to eligible members of our community. Our law school, along with bar associations in the Central District of California, has been asked to contribute volunteers to hand out naturalization certificates to new citizens at large ceremonies in November when as many as 36,000 new citizens will receive the Oath of Allegiance. Unless enough people volunteer for a full day's help, those eligible for citizenship could wait long into 1986 and beyond. The U.S. District Court plans to conduct naturalization ceremonies at the L.A. Convention Center on November 13, 14 and 15, and on November 20, 21 and 22, 1986 - Wed., Thurs. and Fri. of each week. Loyola Law School will be acknowledged in the printed program at the ceremonies and all who participate will receive certificates of appreciation from the U.S. District Court.
