In this issue, we focus on the proceedings of the *MillionTreesNYC, Green Infrastructure and Urban Ecology Research Symposium* held in the spring of 2010 in New York City. The *MillionTreesNYC* Initiative is a comprehensive urban greening and education program that is truly trans-disciplinary in scope and participation (www.milliontreesnyc.org).
