# ABA WRITING COMPETITION

The Medicine and Law Committee of the Tort and Insurance Practice Section of the American Bar Association is sponsoring a writing competition for law students. The winner will receive a \$1,000.00 cash prize.

Papers will be considered on any topic pertaining to medicine and law, and must be approximately three thousand words in length. All students at ABA-accredited law schools are eligible. Manuscripts that have been accepted for publication are ineligible. Submissions must be the work of one person. Entries will be judged on originality, analysis, composition, and style. The winning paper will be considered for publication in the Section's Journal, <u>The</u> <u>Tort & Insurance Law Journal.</u>

Law students wishing to enter the writing competition should submit their papers to: John V. Henry, 29th Floor, 220 East 42nd Street, New York, NY 10017. For purposes of anonymity, the contestant's name should not appear on the manuscript; each paper should be accompanied by a cover letter that includes the student's name and school mailing address. Each submission will be acknowledged in writing. Entries must be postmarked no later than May 1, 1987. The winner will be announced at the American Bar Association Annual Meeting in San Francisco during August 6 - 13, 1987.

# N.L.F. LEGAL ESSAY CONTEST

The National Legal Foundation of Virginia Beach, Virginia is pleased to announce its' Third Annual Legal Essay Contest for law students. The topic is:

> "Parental Rights in Public, Private and Home Education: An Historical Analysis of State and National Constitutional Guarantees, Including the First, Ninth and Tenth Amendments and the Due Process Clause of the Fourteenth Amendment to the United States Constitution."

The actual essay must be submitted and postmarked by May 1, 1987. First Place will be awarded \$5,000.00; Second Place will be awarded \$3,000.00; Third Place will be awarded \$2,500.00.
